## **SECTOR PROFILE**

Pakistan is endowed with huge reserves of minerals covering an outcrop area of 600,000 sq. Kms. There are 92 known minerals of which 52 are commercially exploited with a total production of 68.52 million metric tons per year.

The sector is a promising one with an average growth of 2-3% per annum, existence of above 5,000 operational mines, 50,000 SMEs and direct employment of 300,000 workers.

Despite huge potential, contribution of mineral sector to Pakistan's GDP is around 3 % and country's exports are only about 0.1% of the world's total.


